Kaela Patterson called the meeting to order. Quorum established at 6:50 pm.

**Carry Over Grant:** Jean requested approval of the Head Start Carryover Supplement that requests MHCC carryover \$550,000 that will be used as follows:

- \$400,000 is dedicated to the Sunrise project build out of first floor to provide six Head Start Classrooms, office space and kitchen.
- \$120,000 in minor renovations of the Cleveland Center, which were not completed during the past year due to permitting time.
- \$30,000 in indirect funds.

Courtnee Holm moved to approve the Head Start Carryover Supplement Grant, Holly Curtiss seconded. Motion carried.
